We are pleased to announce Huron Valley Steel Corp. and Fritz Enterprises Inc. will be offering **FREE onsite biometric health screenings** to all benefit eligible employees and spouses again this year. This worksite well-being program is designed to provide information and tools to help manage your current health status or improve on areas that demonstrate future risk. In addition to offering this program to you at no charge, we will provide an incentive for meeting the qualifying criteria and improving your health over time.

After completing your biometric health screening, you will receive a health report containing your biometric measurements to give you an objective view of your health risks and link those risk factors to your lifestyle choices. The information obtained is strictly confidential and will not be shared with anyone at Huron Valley Steel or Fritz Enterprises.

## **How To Schedule Your Screening**

Scheduling your biometric health screening appointment is easy and found within your wellness portal at <a href="https://www.kapnickstrive.com/hvsfei">www.kapnickstrive.com/hvsfei</a>. You will be able to schedule your appointment starting July 13, 2023. All screenings are conducted by a professional, certified team of nurses and phlebotomists.

## **Completing Your Health Risk Assessment (HRA)**

Wellness incentive criteria also includes completing an online Health Risk Assessment (HRA) prior to completing your biometric health screening. If you have already logged into your wellness portal this year, you should have already completed the HRA as it immediately pops up for completion. A lifestyle report is generated from your HRA responses and available for review on the assessment page of your portal. ### **2024 Financial Incentive**

Completing a 2023 screening and meeting qualifying criteria will provide eligibility for the annual wellness incentive to be applied in 2024.

- <u>First-time participants</u> are automatically eligible for the wellness incentive upon completion of their HRA and biometric health screening.
- <u>Participants that have completed a screening in the previous year</u> will need to achieve a Health Score of 70 or higher OR improve their previous Health Score by 5 points to become eligible for the incentive.

If you are a repeat participant and do not receive a Health Score of 70 or higher and/or do not improve your previous year score by 5 points, you are still eligible to receive the incentive by completing our Reasonable Alternative Standard (RAS) program. This is a telephonic health coaching program in which you will speak with a health coach over the phone once a week for 6 weeks to review your health results and create a plan to achieve your health and wellness goals. You may enroll in this program after receiving your health report by contacting Kapnick Strive at strive@kapnick.com or call 877-233-2296. Please enroll in the program by October 27, 2023 and have it completed by December 8, 2023.

#### **Accessing Your Health Report**

Seven to ten business days after completing your screening, your health report can be accessed on the wellness portal at www.kapnickstrive.com/hvsfei. Your report will contain your personal health score, a number derived from only your biometric screening results on a scale from 0-100, with 100 being the perfect picture of health. Please note: Due to HIPAA regulations, we will not except outside health information from your physician in order to be eligible for the well- ness incentive.
