











# **Eversight Strives for Wellness**

To: All Benefits Eligible Eversight Employees *March 1, 2024* 

We are pleased to provide the Eversight STRIVE for Wellness onsite biometric screenings again to all benefits eligible Eversight employees. This wellness biometric screening program is designed to better enable you to know your numbers and manage your existing health or improve on areas that demonstrate future risk. In addition to offering this program to you at no charge, we will again provide an incentive for meeting the qualifying criteria and improving your health over time.

After completing your health screening, you will receive a health report via your wellness portal account containing your biometric measurements to give you an objective view of your health risks and link those risk factors to your lifestyle choices. The information obtained is strictly confidential and will not be shared with anyone at Eversight.

# **How To Schedule Your Screening**

Scheduling your biometric screening appointment is easy and found within your Eversight wellness portal at <a href="https://www.kapnickstrive.com/eversight">www.kapnickstrive.com/eversight</a>. You will be able to schedule your appointment starting April 1, 2024. All screenings are conducted by a professional, certified team of nurses and phlebotomists.

# **Completing Your Health Risk Assessment (HRA)**

Incentive criteria also includes completing an online Health Risk Assessment (HRA) prior to completing the biometric health screening. You will be able to complete the 2024 plan year HRA starting January 1, 2024. A lifestyle report will be generated from your HRA responses and available for review on the assessment page of your portal account. # **Accessing Your Health Report**

Seven to ten business days after completing your screening, your health report can be accessed on the wellness portal at <a href="https://www.kapnickstrive.com/eversight">www.kapnickstrive.com/eversight</a>. Your report will contain your personal health score, a number derived from only your biometric screening results on a scale from 0-100, with 100 being ideal.

#### 2024 Financial Incentive

Participants are eligible to receive a \$500 deduction on their health insurance premium by meeting the qualifying criteria. The \$500 wellness incentive is deducted incrementally from your 2024 bi-weekly health insurance premium. For those who waive coverage, the incentive is added to your waiver dollars.

**Compliant** indicates that the participant completed their plan year HRA as well as a biometric health screening and received a health score of 70 or higher OR improved their previous score by 5 points.

**Non-Compliant** indicates that the participant completed their plan year HRA as well as a biometric screening but did NOT score 70 or higher <u>OR</u> improve by 5 points from their previous score.

# **Reasonable Alternative Standard (RAS) Programs**

Incentive Structure	Incentive
First-Time Participant	Eligible for \$500 Incentive
Repeat Participant - Compliant	Eligible for \$500 Incentive
Repeat Participant - Non-compliant & completes RAS Program	Eligible for \$500 Incentive
Repeat Participant - Non-compliant & does not complete RAS program	Not Eligible for \$500 Incentive

If you are a repeat participant and non-compliant, you are still eligible to receive the incentive by enrolling into the Kapnick Strive Reasonable Alternative Standard (RAS) program. This is a 6-week program in which you will speak with a health coach once a week over the phone to review your health results and create or manage your health goals.
